

recommending against non-essential travel to the Hotel's location and such travel warnings are in effect 60 days or fewer before the first scheduled arrival date.(b) an applicable governmental body responsible for public health in the Hotel's location prohibit entry to individuals from the Group attendees' Home Location or require such individuals to quarantine on arrival, and such prohibitions or requirements are in effect 60 days or fewer before the first scheduled arrival date; and/or (c) an applicable governmental body responsible for public health in the Hotel's location issues guidance or rules limiting the size of a meeting or event such that fifty percent (50)% or more of the Group would be prohibited from attending. If the parties are not able to reach an agreement on an amendment to the Agreement, then Group may terminate this Agreement. If Client terminates the Agreement under this section, Client will pay Hotel as set forth in the chart that follows a percentage of the Cancellation Charges set forth in the section of this Agreement titled "Event Cancellation Conditions".

If notice is received from 29 to the first day of the Event	(50% of the Cancellation Charges)
If notice is received from 59 to 30 days to the first day of the Event	(25% of the Cancellation Charges)
If notice is received between the date of the Agreement signing through 60 days from first day of the Event	(0% of the Cancellation Charges)

Hotel agrees to credit 100 % of the Cancellation Charges owed under this section to the master account of a future Group event of the same or higher total anticipated revenue to the Hotel that takes place on the Hotel's premises [within 12 months after the last contracted program date.

Counterparts/Electronic Signature


This agreement may be executed in one or more counterparts with an original signature or with a hotel-approved electronic signature, each of which shall be deemed an original and all of which shall constitute the same instrument. Further, if a signed agreement is provided to hotel as a photocopy, fax, PDF or other format through a hotel-approved electronic software system, then such agreement shall be treated as original and shall have the same binding effect as an original and shall be acceptable to hotel to hold the guest's rooms block and meeting space as set forth herein.

Agreement Conclusion

This agreement, along with its attachments (if any), contains all of the terms agreed to by the parties. All prior agreements verbal or written are no longer effective once this agreement is signed. Should any conflict between this agreement and any other agenda, exhibits or attachments the language of this agreement shall control once signed by each party's authorised representative. This agreement shall constitute a binding agreement between group and the hotel.
